How do I qualify to become an AmeriCorps member through People Inc.?

- Be at least 18 years of age AND
- Have a high school diploma or equivalent (some exceptions apply) AND
- Be a citizen, national or lawful permanent resident alien of the United States

How can I apply?

To view available AmeriCorps service opportunities at People Inc., visit the My AmeriCorps Portal (my.americorps.gov), click "Search listings," then at Program Name, enter People Inc. ETHOS. Review all of the listings, select Apply Now and register.

Those who have served in the U.S. Military (including the Guard and Reserve), their families and people with disabilities are encouraged to apply.
